I, Vidhya Baid, Practising Company Secretary (FCS:- 8882/CP:- 8686) and proprietor of M/s. My responsibility as a Scrutinizer is to ensure that the voting process both through e-voting and by use of postal ballot forms are conducted in a fair and transparent manner and render Scrutinizer's Report of the total votes cast "in favour" or "against" if any, on the resolutions to the Chairman/Authorized Personnel, based on the reports generated from the electronic voting system provided by National Securities Depository Limited (NSDL) and of voting through postal ballot forms.

I submit my report as under:

- The e-voting period and voting through Postal Ballot remained open from Thursday, 16th November, 2023 at 9.00 a.m. and ended on Friday, 15th December, 2023 at 5.00 p.m.
- 2. The Shareholders holding shares as on the "cut off" date, i.e. 3rd November, 2023 were entitled to vote on the proposed resolutions as mentioned in the Postal Ballot Notice dated 10th November, 2023 of the Company.
- 3. The Company has sent postal ballot forms along with the Postal Ballot Notice dated 10th November, 2023 to eligible shareholders to enable them to cast their the votes through postal ballot forms in case they does not wish to cast their vote through e-voting facility.
- 4. All postal ballot forms received till 15th December, 2023 upto 5.00 PM, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny. The sealed and tamper

- proof ballot box was kept under my safe custody before commencing the scrutiny of postal ballot forms. The locked box was subsequently opened in my presence.
- 5. The votes cast under e-voting facility were unblocked on Saturday, 16th December, 2023 around 01.30 p.m. in the presence of two witnesses, namely, Mr. Karan Singh, residing at 351 N S Road, Howrah 711101 and Mr. Anil Prasad residing at Tara Ma Mandir, Near Gobra Railway Station, Howrah -712702, who are not in employment of the company.
- 6. I have scrutinized and reviewed the votes tendered based on the data downloaded from the NSDL e-voting system and through postal ballot forms. No ballots were found invalid.
