Dear Sir,

I, RINKU GUPTA, (FCS-9237/CP-9248) of M/S Rinku Gupta & Associates, Company Secretaries in Whole time Practice had been appointed as the Scrutinizer by the Board of Directors of your Company pursuant to Sections 108 & 110 of the Companies Act, 2013 (the Act) read with Rule 20 & 22 of the Companies (Management and Administration) Rules, 2014, as amended, to scrutinize the entire process of voting conducted through E-Voting and through Postal Ballot Forms received from the shareholders in respect of the resolutions mentioned in the Postal Ballot Notice dated 13th February, 2023.

The Company had availed the e-voting facility offered by National Securities Depository Limited (NSDL) for conducting e-voting by the Members. The Company had also provided Postal Ballot Forms for voting to the Members who does not wish to cast their vote through e-voting facility.

The Members holding shares as on the cut-off date (5^{th} May, 2023) were entitled to vote on the proposed resolutions as set out in the Postal Ballot Notice dated 13^{th} February, 2023. The voting period commenced on Thursday, 11^{th} May, 2023 at 9:00 a.m. (IST) and ended on Friday, 9^{th} June, 2023 at 5:00 p.m. at 5:00 p.m. (IST).

I have scrutinized and reviewed the votes tendered based on the data downloaded from the NSDL evoting system and through Postal Ballot Forms.

Particulars of all Postal Ballot forms received from the members have been entered in a register separately maintained for the purpose.

The Postal Ballot forms were kept under my safe custody in sealed and tamper proof ballot boxes before commencing the scrutiny of such postal ballot forms.

All postal ballot forms received till 9^{th} June, 2023 upto 5.00 PM, the last date and time fixed by the Company for receipt of the forms, were considered for my scrutiny.

The votes cast under e-voting facility were unblocked by me in the presence of two witnesses who were not in the employment of the Company and after the conclusion of the voting period.

The Management of the Company is responsible to ensure compliance with the requirements of the Act and rules thereunder relating to remote e-voting.

My responsibility as a Scrutinizer for the E-Voting and Postal Ballot Forms is restricted to making a Scrutinizer's Report of the votes cast in favour or against the resolutions.
